Notes on Standalone Results:

1. The standalone results for the quarter ended June 30, 2009 which were reviewed by the Audit Committee were approved by the Board of Directors at its meeting held on July 22, 2009. The standalone results have been subjected to limited review by the auditors.
2. The sales growth on standalone basis during the quarter ended June 30, 2009 is 16.5%.
3. The only individually reportable business segment is pharmaceutical business.
4. The Ministry of Corporate Affairs has through its notification dated March 31, 2009 provided an option in connection with the treatment of exchange gain /loss on translation of long term foreign currency items under the provisions of Accounting Standard (AS) - 11 "The Effects of Changes in Foreign Exchange Rates". The Company has exercised the option.

Accordingly, during the quarter and year ended March 31, 2009, an exchange loss of Rs.3,463 lakhs had been added to the cost of assets. During the current quarter ended June 30, 2009 as a result of change in exchange rates the said loss has been reduced to Rs.2,535 Lakhs and the difference of Rs.928 Lakhs has been reduced from the cost of assets.

5. The figures for the quarter ended June 30, 2008 and year ended March 31, 2009 have been regrouped, wherever necessary.
